saith, That he did see Robert Anderson sign the Receipt
hereon endorsed, and did himself subscribe his Name
as a Witness thereto

This Indenture, made the 29th Day of October, in the Year
of our Lord one thousand seven hundred and eighty nine, and in
the 13th Year of the Sovereignty, and Independence of the United States
of America, Between Banister Harper, of Pendleton County, in the
State of South Carolina, Planter, of the one Part, and William Harper,
of the County and State aforesaid, Son of the said Banister Harper,
of the other Part — Witnesseth, That the said Banister Harper, as
well for and in Consideration of the natural Love and Affection which
he hath and beareth unto him his said beloved Son William Harper,
as also of the sum of Twenty Shillings current Money of the State
aforesaid to him in Hand paid by the said William Harper, he the
said Banister Harper hath given, granted and confirmed, and
by these Presents doth give, grant and confirm unto his said Son
William Harper, one Negro Woman Slave named Cheaney, in
what Place soever the said Negro Wench shall be found, as well
in his own Possession and Custody, as in the Custody or Possession of
any other Person or Persons whatsoever, as she now is, or which at
any Time hereafter during the Life of the said Banister Harper
may be improved or increased, except one Child which said Ne-
gro Woman has had named Daniel — To have and to hold
the said Negro Woman named Cheaney, with her Increase
as aforesaid, unto the said William Harper, his Heirs, Execu-
tors, Administrators, and Assigns, for ever — Provided always,
and upon Condition, That he the said William Harper, his Heirs,
Executors, Administrators and Assigns, do, and shall permit and

and suffer him the said Banister Harper to have, hold, use, occupy, possess, and enjoy the said Negro Woman named Cheaney, with her Increase above granted, for and during so long a Time as the said Banister Harper shall happen to live — And the said Banister Harper for himself, his Executors and Administrators, doth grant, and agree, to and with the said William Harper, his Executors and Administrators, That the said William Harper, his Executors and Administrators, by and under the Conditions aforesaid, and not otherwise, shall and may peaceably and quietly have, hold, and enjoy, the Negro Woman aforesaid, in Manner aforesaid, without any molestation, Hindrance, or Interruption by any Person or Persons whatsoever claiming under him, or by his Act, Means, or Procurement. — — — In Witness whereof the said Banister Harper hath hereunto set his Hand and Seal the day and Year first above written.

This Deed of Gift is signed by Banister Harper on the express Condition, That in Case he should die before the 1st Day of January 1791, that the said Negro Woman named Cheany shall not be taken from his Widow before that Time, viz. the 1st Day of January one thousand seven hundred and ninety-one, to whom he will will her for that Term.
